

Community Accountability Diversion ("CAD") Programs

To Our Partners,

We have composed the following basic descriptions of the diversion programs administered by CorrectiveSolutions. The two and four month programs are done on both a pre-filing and post-filing basis. In the PC 1000 Program, the initial contact procedure for the defendants is to call the Program at (855) 331-7967. They will be asked to pay the \$40 enrollment fee and schedule a Diversion Plan Conference ("DPC"). The same procedure applies to the defendants in post-filing cases, except the number to call is (855) 211-0580. In pre-filing cases, CorrectiveSolutions initiates contact on behalf of the District Attorney's Office. Defendants are encouraged to pay their fees either through a case coordinator in our call center, through our self serve telephone Interactive Voice Response ("IVR") system, or online at our website, www.diversionprogram.org. Additionally, defendants can mail payments to the local P.O. Box. If necessary, defendants can make payments in person at our office at 2400 County Center Drive, Suite B, Santa Rosa, CA 95403.

PC 1000 Drug CAD Program

- Six month program
- Diversion Plan Conference
- Two additional individual counseling sessions
- Eighteen hours of drug and alcohol education
- Referrals to community resources
- Twelve hours of community service
- Random drug testing (4 tests)
- Fees of \$625.00, of which \$40.00 is due at enrollment, payment plans available for balance
- Additional conditions may be imposed or referrals recommended

It is possible for defendants who live out of the area to complete the program in their community. However, any additional costs will be the responsibility of the defendant.

Two Month CAD Program (Post or Pre-Filing)

- Diversion Plan Conference
- Community Accountability class – one session
- Referrals to community resources
- Four hours of community service
- Fees of \$295.00, of which \$40.00 is due at enrollment, payment plan available for balance
- Additional conditions may be imposed or referrals recommended

It is possible for defendants who live out of the area to complete the program in their community. However, any additional costs will be the responsibility of the defendant.

Four Month CAD Program (Post or Pre-Filing):

- Diversion Planning Conference
- Referrals to community resources
- Community Accountability class – one session
- Eight hours of community service
- Fees of \$375.00, of which \$40.00 is due at enrollment, payment plans available for balance
- Additional conditions may be imposed or referrals recommended

It is possible for defendants who live out of the area to complete the program in their community. However, any additional costs will be the responsibility of the defendant.
